1 The pCon.catalog Plugin

pCon.catalog Plugin for Autodesk® Revit® software, you can import intelligent furniture models from pCon.planner PRO into your Revit® projects. For this, pCon.planner PRO generates export files in the new RGFX format. These files can be loaded in your Revit® plan with the help of the *pCon.catalog Plugin*. In addition to geometrics, the most important pieces of information for each article is transferred to Revit®.

2 Installing the Plugin

Please download the *pCon.catalog Plugin*. Click on setup file and follow the installation instructions. You will then see the *pCon.catalog Plugin* as an additional tab on the Quick Access Toolbar.

3 Exporting RGFX files from pCon.planner PRO

Please be sure to configure the item while still in pCon.planner PRO. The model cannot be reconfigured in Revit®.

To export the article for Revit®:

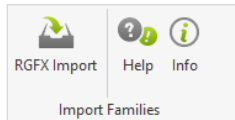
1. Open the desired plan in pCon.planner PRO.
2. Click on the Application Menu and choose *Export* drawing to *pCon* format.
3. Select the folder in which you would like to store the export for Revit®.
4. Under File Type, select *Revit® Exchange Format (*.rgfx)*.
5. Name the file and click *Save*.
6. You will then see a dialog with the option *Export selection only*. If this is activated, only the previously selected articles will be transferred. If this option is not activated, pCon.planner PRO will export all articles from the plan into the RGFX file.

The items will then be saved locally as an RGFX file. Now, you can import these articles into Revit® using the Plugin. If you are working in a team, you can also send the file via email.

Please Note: pCon.planner PRO exports standard articles and their configurations in RGFX format. Manual articles will not be transferred into RGFX format. Room elements, such as walls or wall element, will also not be exported.

4 Importing RGFX Files into Autodesk® Revit®

To insert an item from pCon.planner PRO into Revit®:



1. Start Revit® and open an existing project or create a new one.
2. Under the Quick Access Toolbar, switch to the tab labeled pCon.
3. Click on *RGFX Import*.
4. Choose an RGFX file and click *Open*.
5. Click the position in the plan where you would like to insert the articles.
6. The articles from the RGFX file will now be imported as Revit® Family.

Please Note: In order to quickly and easily place models into the project, we recommend using a 2D view.

5 Working with RGFX-imported data in Revit®

You can work with the imported models just as you would any other Revit® Family: Moving or editing the group as a whole. You can select a single item within the group, for example, in order to reposition it.

5.1 Retrieving article information

When you import a single item, it will be directly inserted as a Revit® Family. If several items are available, they will be lumped into one group. To view the information for an article within a group:

1. Select the article group.
2. Open the group to edit.
3. Select one item within the group.
4. You can now see the article information as usual.

Please Note: After Revit®, imported articles can only be reimported into pCon.planner PRO using specific file types, such as a DWG import. You will, however, lose article information in the process.
